Provide necessary training on intelligence and the role of Colorado's residents and public safety professionals (including peace officers, firefighters, emergency medical technicians and other first responders) in preventing mass attacks and criminal acts through Prevention Programming.

CTIS

In Colorado, we leverage many different resources to meet the growing demands on those working to support cybersecurity for their organizations. One of the most critical resources is the Colorado Threat Information Sharing network (CTIS), a platform for information and threat sharing, and community collaboration.

CTIS is for those professionals charged with supporting cybersecurity in their organization. There are multiple work groups for members to participate in so that users can further focus the information they get that pertains to them. CTIS is not a duplicative effort, we recognize that many local governments and critical infrastructure partners already get regular updates on national-level threats and trends.

Instead, CTIS is meant to accelerate information sharing that is local to Colorado jurisdictions, in real time, so we can enhance our response against potential threats.

Expand use of grants and funding for statewide benefit and foster initiatives to provide training to teachers and veterans

Established a Threat Intelligence Sharing and Community Program

Manage and disseminate threat intelligence information through community collaboration called the Colorado Threat Information Sharing network
